# 261/23 Recording and Filming of Council and Committee Meetings

### 265/23 Transfer of Car Park Trust Land

Land Registration documents form TP1 and associated plan had been received in duplicate from BRM Solicitors and were put forward for signature and application of the Parish Seal in accordance with Ashover Parish Council Standing Order 23. The Chairman of the Parish Hall put forward copies of form TP1 signed by Trustees. Members agreed to only sign documents provided by the Parish Council's solicitor and return these, as instructed, to BRM Solicitors

Resolution: That the Parish Seal is applied to the Land Registration form TP1 and associated plan for the transfer of car park trust land back to Ashover Parish Council and that the Chairman and Vice-Chairman sign the documents in accordance with Standing Order 23.

# 266/23 Urgent Matter: Request for Additional use of Junior Football Pitch

Consideration was given to a request from Ashover Junior FC for a third team to play on the Junior Pitch during the forthcoming football season. A concern was raised regarding overplaying of the junior pitch.

Resolution: That permission for 3 junior teams to play on the junior pitch ONLY, would be given. However, this would be for one season, to allow for assessment of the ongoing pitch condition to be monitored. A new application to Ashover Parish Council would be required for the following season and a decision would be made based on the results of pitch condition during the forthcoming season.
