- d) Members asked if a 'Change of Use' was required from agricultural to domestic.
- e) Ashover Parish Council requests that previous observations made under application 22/00504/FL are considered.

## 184/23 Health & Safety

Dry stone walls in the cemetery had been repaired and rebuilt to a high standard (Minute 165/22). Following recent national press reporting on dog attacks on walkers, the requirements to limit the number of dogs walked at any one time under the 'Public Space Protection Order' was highlighted.

Resolution: That information on 'Dog Management Public Space Protection Order' is circulated in the newsletter and on the website etc.

#### 185/23 Parish Maintenance

Ashover Community Medical Centre Ltd. had funded the replacement of 6 defibrillator cabinets sited around the parish. The cabinets were heated and lit which would result in a nominal expense to 4 of the sites. Keys to the cabinets, to enable code change, had been ordered.

Parish planters had not been planted-up for the Autumn/Winter period and communication with the contractor regarding this was reported. Members considered that planters should be retained.

It was proposed and seconded that no winter 2022/23 planting takes place, a discount is sought for summer 2023 planting, trailing plant are used in the Narrowleys Lane planter, performance of the contractor is monitored and estimates for the contract are sought prior to the end of the current contract in summer 2024. Members voted 6 to one for the proposal. **Resolution:** 

- (i) That an offer of a donation towards the electricity for 4 of the cabinets is made to the property owners/occupiers.
- (ii) That the purchase of 3 code change keys to the cabinets is approved to prevent theft etc. of the defibrillators.
- (iii) That the contractor does not fill planters for winter 2022/2023 and a discount is sought for summer 2023 planting and that trailing plants are used in the Narrowleys Lane planter.
- (iv) That the contractor's performance on the planters is monitored and a written notification issued if this fails the expected standard.
- (v) That estimates are sought for planting and maintenance of flower displays around the parish in spring 2024.

## 186/23 Parish Events
